1. PRESENTATION

1-A. MONTEREY PARK COMMUNITY HEALING FUND UPDATE

City Treasurer Lee provided an update on the funds raised by the Monterey Park Community Healing Fund for victims of the Mass Casualty Incident (MCI) that occurred on January 21, 2023. She stated that the amount raised to date is \$65,829 and applications are currently being accepted for grant funding for victims of the MCI. City Treasurer Lee mentioned that the Community Healing Fund has received about 35 applications, and those applications are currently being reviewed. The last day to submit applications is on July 31.

1-B. DEVELOPMENT PROJECT UPDATE

Economic Development Manager Torres presented a PowerPoint presentation detailing the various retail and commercial projects around the City of Monterey Park.

1-C. U.S. SMALL BUSINESS ADMINISTRATION (SBA) ECONOMIC INJURY DISASTER LOAN (EIDL) PROGRAM UPDATE

Economic Development Manager Torres presented a PowerPoint presentation detailing the Small Business Administration's (SBA) collaboration with the Pacific Asian Consortium for Employment (PACE) and the city of Monterey Park to provide Economic Injury Disaster Loans (EIDL) to small businesses adversely affected by the city MCI. The event took place this past June. The event generated 117 EIDL applications, three of which have already been approved for a total of \$604,500. Barbara Nitis, Public Information Officer with the SBA, was available to answer questions.

2. OLD BUSINESS

2-A. SAN GABRIEL VALLEY REGIONAL HOUSING TRUST ("SGVRHT") MEMBERSHIP

On April 5, 2023, the City Council received a presentation from the San Gabriel Valley Regional Housing Trust. City Council gave direction to research the process for joining the SGVRHT.

There are two types of membership types that are available, including affiliate membership, which does not allow access to project funding, and full membership, which allows access to project funding and other benefits.

The City Council should consider the following:

- 1. Whether the City Council would like to join the SGVRHT; and
- 2. If so, at what membership level?

Should the City Council decide to authorize the City Manager to join the SGVRHT, the City Council would also need to authorize a budget amendment appropriating funds from the General Fund to cover annual costs for the selected membership level.

Public Communications:

- Ricki Choi, Director of Government and Community Relations, San Gabriel Valley Council of Governments (SGVCOG), addressed the City Council's inquiry regarding the amount of funding provided per housing projects.

Discussion: Community Development Director Serrano provided a PowerPoint presentation to the City Council.

Recommendation: It is recommended that the City Council consider (1) Providing staff direction regarding the City Council's desire to join the SGVRHT and at what membership type, affiliate membership or full membership; (2) If desirable:

- a. Authorize the City Manager to prepare a letter to join the SGVRHT as an affiliate member, with no access to project funding, for amount of \$12,042.14 for the first year and thereafter, an ongoing annual fee of \$3,042.14 plus annual Consumer Price Index ("CPI") increase; **OR**
- b. Authorize the City Manager to execute an agreement with SGVRHT, in a form approved by the City Attorney, to join the SGVRHT as a full member, with access to project funding, for amount of \$24,210.68 for the first year and thereafter, an ongoing annual fee of \$15,210.68 plus annual CPI increase: AND
- c. Budget amendment appropriating funds from the General Fund to cover annual costs for the selected membership level;

(3) Taking such additional, related, action that may be desirable.

Action Taken: The City Council authorized the City Manager to execute an agreement with SGVRHT as a full member, with access to project funding, for amount of \$24,210.68 for the first year and thereafter, an ongoing annual fee of \$15,210.68 plus annual CPI increases.

Representatives of the City of Monterey Park ("City") and MPPOA met and conferred to negotiate the terms and conditions of a new Memorandum of Understanding ("MOU") regarding employment. The parties reached an agreement on an MOU effective July 1, 2023 to June 30, 2025.

3-D. PROFESSIONAL SERVICES AMENDMENT WITH HF&H CONSULTANTS, LLC FOR WATER, WASTEWATER, AND SOLID WASTE RATE STUDIES

In May of 2021, staff prepared specifications for a Request for Proposal (RFP) for a consultant to perform a comprehensive rate study for the City's water, wastewater, and solid waste operations and received four responses. HF&H was the selected consultant. On June 16, 2021, Council approved a contract between the City and HF&H Consultants. The study has taken longer to complete than anticipated and the City is requesting to amend and extend the contract with HF&H to complete and implement the Study.

The City is requesting an amendment for an additional amount of \$295,000 plus a 10% contingency equal to \$26,500 for a total not to exceed amount of \$437,095 and an extended term through December 31, 2024.

Action Taken: The City Council authorized the City Manager to execute an amendment with HF&H Consultants, LLC in a form approved by the City Attorney; to conduct a Proposition 218 utility rate study for an additional amount of \$291,500 and extend the term of the amendment through December 31, 2024 and appropriated \$190,700 from Refuse Fund (421) to the FY 2023-24 Budget.

3-E. 2020 URBAN AREAS SECURITY INITIATIVE (UASI) PROGRAM - CONTINGENCY FUNDS UPDATE

The Urban Area Security Initiative (UASI) Grant Program is a Homeland Security Grant designed to enhance regional preparedness and capabilities in designated densely populated, high-threat areas. Currently, the City of Monterey Park Fire Department (Department) is participating in the 2020 UASI Grant Program. The Department was notified of an approved modification for an increase of \$4,404. As per Resolution No.11740 adopted by the City Council on May 6, 2015, staff is reporting to the City Council the type of money obtained and the project details.

Action Taken: The City Council received and filed the report, on Consent Calendar.

3-F. 2020 STATE HOMELAND SECURITY GRANT PROGRAM – COST SAVINGS PROJECTS

The City of Monterey Park Fire Department was notified of an approved modification for an increase of \$7,593 for the 2020 State Homeland Security Grant Program (SHSP 2020 Grant). As per Resolution No. 11740 adopted by the City Council on May 6, 2015, staff is reporting to the City Council the type of money obtained and the project details.

3-G. STATE HOMELAND SECURITY PROGRAM SUBRECIPIENT AGREEMENT GRANT YEAR 2022 – AWARD OF AGREEMENT

The County of Los Angeles is a Subgrantee of the State Homeland Security Program Grant Year 2022 that is provided by the U.S. Department of Homeland Security. Per the subrecipient agreement, the County of Los Angeles is authorized to enter a subrecipient agreement with the City of Monterey Park, which includes a distribution of SHSP 2022 grant funds to the City of Monterey Park in the amount of \$230,000. The award is dedicated to fund a Regional Training Group (RTG) Intelligence Chief position, in the amount of \$230,000. Staff recommends the City Council to authorize the City Manager to execute an agreement, in a form approved by the City Attorney, with the County of Los Angeles for an amount not to exceed \$230,000 for the SHSP 2022 Grant.

3-H. CANNABIS TAX FUND GRANT PROGRAM (CTFGP) FUNDING FOR FISCAL YEAR 2023/2024

The City of Monterey Park Police Department was notified of an award of \$184,010.89 from the Department of California Highway Patrol (CHP) Cannabis Tax Fund Grant Program (CTFGP) for Fiscal Year 2023/2024. The police department will utilize the grant funding to reduce and mitigate the impacts of impaired driving in our community.

3-J. AUTHORIZE PURCHASE OF TRANSIT VANS FOR DIAL-A-RIDE PROGRAM

Two Dial-a-Ride vehicles have reached their useful service life and are due for replacement. Staff has identified the Class V - MobilityTRANS V350 transit vans as the most suitable replacement for use in the Dial-a-Ride program and recommends their purchase through Creative Bus Sales. The total cost for both vehicles is \$170,797.58 including applicable taxes and fees.

Action Taken: The City Council waived the bidding requirements pursuant to Monterey Park Municipal Code Section 3.20.050(4) and authorized the City Manager to execute a contract with Creative Bus Sales, in a form approved by the City Attorney, not to exceed \$170,797.58 for the purchase of two Class V – MobilityTRANS V350 transit vans for the City's Dial-a-Ride program.

3-K. BARNES PARK AMPHITHEATER SEATING UPGRADES

The City's Capital Improvement Plan (CIP) includes Project No. 95028 for Barnes Park Amphitheater seating improvements. The proposed work includes the replacement of existing seats and lighting to improve the performance and ceremony viewing experiences for the community.

In February 2023, Public Works staff, in collaboration with the Recreation Department, researched and identified seating material that would be a suitable replacement for the existing Amphitheater seating. City Staff identified BuyBoard as a company that has an agreement with Irwin Seating Company for procurement of the Amphitheater seating. Once the seating was identified, staff solicited informal bids for the installation of the seating from three contractors: Irwin Seating Company, RE Schultz, and Zoom Recreation. Irwin Seating Company submitted the lowest bid for installation. It is recommended that City Council authorize the purchase of seating material from Irwin Seating Company utilizing the discounted pricing provided by the BuyBoard agreement and also award a public works contract for the installation of new seating.

CEQA (California Environmental Quality Act):

Since the proposed work is a minor alteration to an existing public facility, this project is Class 1 Categorically Exempt pursuant to the California Environmental Quality Act (CEQA).

4. PUBLIC HEARING

4-A. PUBLIC HEARING AND APPROVAL OF THE 2023-2024 ANNUAL ACTION PLAN AS REQUIRED BY THE COMMUNITY DEVELOPMENT BLOCK GRANT, AND HOME INVESTMENT PARTNERSHIPS PROGRAMS

The U.S. Department of Housing and Urban Development provides funding to states, counties and cities in the form of Community Development Block Grant (CDBG) and HOME Investment Partnerships (HOME) funds. Since the City of Monterey Park is an Entitlement City, the City is eligible to receive both CDBG and HOME funds which it has for many years.

Before Monterey Park can receive these funds, federal regulations require that a Consolidated Plan (i.e., five-year plan) be adopted by the City that serves as the federal planning document for those jurisdictions receiving CDBG and HOME Investment Partnerships HOME Program funds. The Consolidated Plan was adopted by the City Council in 2020. In addition, federal regulations also require the adoption of an Annual Action Plan to the Consolidated Plan that operates on a single program year established by the City (i.e., July 1, 2023 through June 30, 2024). As required by federal requirements, the City will submit its One Year Annual Action Plan to the U.S. Department of Housing and Urban Development (HUD) by the statutory deadline of August 16, 2023.

The City of Monterey Park views the Annual Action Plan requirements as an opportunity to reassess its housing needs and priorities, as well as its programs and resources in a manner that will best meet the affordable housing and community development challenges of the Monterey Park community. The estimated City entitlement for FY 2023-24 is \$588,076 in CDBG funding and \$375,733 in HOME funding.

Action Taken: The City Council (1) opened the public hearing at 10:54 p.m. to receive public testimony and documentary evidence and closed the public hearing at 11:09 p.m. with no registered speakers; (2) approved the One-year Action Plan (Action Plan) for Fiscal Year 2023-2024 for the Community Development Block Grant ("CDBG"), and HOME Investment Partnerships ("HOME") Programs; (3) directed staff to prepare and transmit the final documents to the U.S. Department of Housing and Urban Development ("HUD"); and (4) authorized the City Manager, or his designee, to take all actions necessary or desirable to implement the Annual Action Plan, and Subrecipient Agreements.
